SB 415 became effective January 1, 2018; it required subject public agencies to either (i) officially change their election date by no later than January 1, 2018, or (ii) adopt a plan by January 1, 2018, to eventually change their election date by no later than the November 8, 2022 Statewide General Election. On February 28, 2017, LACSD Board of Directors adopted Resolution No. 2017-03 recommending that board member elections move from odd-number years to even-numbered years. The San Bernardino County Board of Supervisors approved the change and as a result, the current board member terms were extended by one year.
