

ORDINANCE NO. 11

AN ORDINANCE OF THE BOARD OF
DIRECTORS OF THE LAKE ARROWHEAD
COMMUNITY SERVICES DISTRICT, SAN
BERNARDINO COUNTY, CALIFORNIA,
ESTABLISHING AND PROVIDING FOR
AN ENERGY ADJUSTMENT CHARGE AND
THE PERIODIC INCREASE THEREOF

WHEREAS, energy costs have been increasing dramatically with the resultant increase in costs of providing domestic water service; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District has determined that it is necessary to pass the energy cost increases on to the water consumer and to provide for the periodic increase in water rates to reflect these cost increases;

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District DOES HEREBY ORDAIN as follows:

Section 1. Energy Adjustment Charge. That an Energy Adjustment Charge of \$2.25 per two month period is hereby established for each active water meter within the District. This charge is established to reflect the increased energy costs to the District of electricity and natural gas.

Section 2. Collection of Charge. The Energy Adjustment Charge shall be collected with and in the same manner as water rates of the District and shall be reflected on the billings sent to the water customers. All remedies of the District for collection of water rates and penalties for non-payment by the customers currently in effect shall


apply equally to the charge provided for herein.

Section 3. Periodic Increase of Charge. The Energy Adjustment Charge shall be periodically adjusted by resolution of the Board of Directors to reflect cost increases and/or decreases of electricity and natural gas. Such adjustments shall be in equal amounts to each active water meter within the District and shall be in an amount sufficient to totally reflect the actual energy cost increase or decrease to the District.


Section 4. Effective Date. This Ordinance shall become effective immediately.

Section 5. Publication. The Secretary is hereby authorized and directed to cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District.




