

ORDINANCE NO. 14

ORDINANCE OF THE BOARD OF DIRECTORS OF THE  
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,  
SAN BERNARDINO COUNTY, CALIFORNIA, AMENDING  
ORDINANCE NO. 13, RELATING TO THE ESTABLISH-  
MENT AND PROVIDING FOR THE ALLOCATION AND  
ISSUANCE OF SEWER CONNECTION PERMITS.

WHEREAS, this Board of Directors has determined that the procedure for the issuance and allocating of sewer permits which generally provides that within thirty (30) days after issuance of an allocation, a sewer permit (which includes the granting of a building permit) must be issued or the allocation will be lost; and

WHEREAS, this Board of Directors has determined that this thirty (30) day period should be increased to forty-five (45) days;


BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Amendment. That Ordinance No. 13, under "Procedure", item No. 8 is hereby amended to increase the "thirty (30) days" to forty-five (45) days" and to insert "building and sewer" between the words "the" and "permit" in line two.


Section 2. Effective Date. This Ordinance shall become effective immediately.

Section 3. Publication. This Secretary is hereby authorized and directed to cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District.
