

ORDINANCE NO. 17

ORDINANCE OF THE BOARD OF DIRECTORS  
OF THE LAKE ARROWHEAD COMMUNITY SERVICES  
DISTRICT, SAN BERNARDINO COUNTY, CALIFORNIA,  
RATIFYING PASSED RATES AND CHARGES, ESTABLISHING  
AND PROVIDING FOR WASTEWATER RATES, CHARGES  
AND CONNECTION FEES; AND PROVIDING FOR THE  
APPROVAL OF THE FINANCING PLAN FOR WASTEWATER  
IMPROVEMENTS PREPARED AND PRESENTED BY BARTLE  
WELLS ASSOCIATES

WHEREAS, the District's Financial Consultants, Bartle Wells Associates have prepared a "Financing Plan for Wastewater Improvements" and presented the Plan to the Board of Directors of this District;

WHEREAS, this Board approved said Plan on April 6, 1984;  
and

WHEREAS, said Plan provides that the District's fee and charges shall be increased on an annual basis for the 1984-85, 1985-86, 1986-87, 1987-88, and 1988-89 fiscal years on or about July 1 of that year; and

WHEREAS, this board of directors on September 23, 1983 by Ordinance No. 13 increased the District's Connection Charges to \$2,751.00 which was increased in 1984 To \$2,827.00 and in 1985 was increased To \$3,110.00; and

WHEREAS, this Board of Directors has annually increased the District's Permit and Inspection Fee from \$108.00 in 1984 to \$117.00 in 1985; and

WHEREAS, this Board of Directors increased the Wastewater User Fee in 1983 to \$155.00, in 1984 to \$200.00, and in 1985 to \$216.00; and

WHEREAS, it is this Board of Directors intention to provide for an annual increase in the District's Connection Charge, Wastewater User Fee, and the District's Wastewater Permit and Inspection Fee:

BE IT ORDAINED, by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Financing Plan for Wastewater Improvements.  
The Financing Plan for Wastewater Improvement presented by Bartle Wells Associates in April 1984 is hereby approved and implemented for the purpose of financing the Capital Improvement Program of the Lake Arrowhead Community Services District Wastewater System.

Section 2. Ratification of Previous Increases in District Rates, Fees, and Charges. The District increases in Permit and Inspection Fees, Connection Charges and User Fees in relation to the District's Wastewater System which were previously approved in 1983, 1984 and 1985 as set forth hereinabove, are hereby ratified and approved.

Section 3. Connection Fee. That a Connection Fee of \$3,110.00 per Equivalent Dwelling Unit (EDU) is hereby established; in addition, this connection fee shall be increased hereby on July 1, 1986 to \$3,421.00 per EDU, on July 1, 1987 \$3,763.00 per EDU and on July 1, 1988 to \$4,139.00 per EDU.

Section 4. User Fees. That the District's Wastewater User Fee is hereby established for the fiscal year 1985-86 as \$216.00 per EDU; in addition, the Wastewater User Fee is hereby increased effective July 1, 1986 to \$260.00 per EDU, effective July 1, 1987 to \$281.00 EDU, and effective July 1, 1988 to \$303.00 per EDU.


This User Fee shall be billed on a bi-monthly basis together with the water bill for water users of the District and shall be payable as one item. For non water users of the District, this fee shall be billed on a quarterly basis.

Section 5. Permit and Inspection Fee. The basic Permit and Inspection Fee of the Wastewater is hereby established at \$117.00; in addition, effective July 1, 1986, this fee is hereby increased to \$126.00, effective July 1, 1987 to \$136.00, and effective July 1, 1988 to \$147.00.


Section 6. Effective Date. This Ordinance shall become effective immediately upon its adoption and is an Urgency Ordinance in order to protect the health and safety of the Community by regulation and controlling the use of the Wastewater Sewerage System of the Lake Arrowhead Community Services District.

Section 7. Publication. The District Secretary is hereby directed to cause this Ordinance to be published once in full in a newspaper of general circulation.
