

ORDINANCE NO. 32

AN ORDINANCE OF THE BOARD OF
DIRECTORS OF THE LAKE ARROWHEAD
COMMUNITY SERVICES DISTRICT, SAN
BERNARDINO COUNTY, CALIFORNIA,
ADOPTING NEW WATER RATES EFFECTIVE
JUNE 1, 1992

WHEREAS, the Board of Directors have reviewed the operational requirements of operating the Lake Arrowhead water system; and

WHEREAS, the Board of Directors desires to establish water rates for the customers of Lake Arrowhead Community Services District which adjust for energy costs, provide funds for system rehabilitation, and encourage water conservation; and

WHEREAS, the Board held public hearings on January 30, 1992 and March 7, 1992, and May 2, 1992, to receive public input.

NOW THEREFORE BE IT RESOLVED by the Board of Directors of the Lake Arrowhead Community Services District that the following rates are established for households, businesses and public agencies within the Lake Arrowhead Community Services District effective June 1, 1992.

1. RESIDENTIAL SERVICE RATE:

A. BASE FEE

1. MONTHLY - \$14.25 (INCLUDES 500 CF OF WATER)
2. BIMONTHLY - \$28.50 (INCLUDES 1000 CF OF WATER)

B. CONSUMPTION RATES: When consumption exceeds the Base Fee:

\$2.35/CCF

2. BUSINESS SERVICE RATE:

A. BASE FEE: (INCLUDES 1,000 CF WATER)

5/8" Meter	--	\$ 28.50	(\$ 14.25 monthly)
1" Meter	--	\$ 57.00	(\$ 28.50 monthly)
1 1/2" Meter	--	\$ 71.25	(\$ 35.63 monthly)
2" Meter	--	\$114.00	(\$ 57.00 monthly)
3" Meter	--	\$171.00	(\$ 85.50 monthly)


2" Meter	--	\$114.00 (\$ 57.00 monthly)

4" Meter	--	\$228.00 (\$114.00 monthly)
6" Meter	--	\$342.00 (\$171.00 monthly)

B. CONSUMPTION RATES: When consumption exceeds the Base Fee:
 \$2.35/CCF


