

ORDINANCE NO. 35

AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA
ESTABLISHING AND PROVIDING FOR WATER RATES AND CHARGES
WITHIN THE DEER LODGE PARK WATER SYSTEM
(AMENDS ORDINANCES NO. 16 AND 22)

WHEREAS, charges are now being collected on a monthly basis in Deer Lodge Park; and

WHEREAS, the Crestline-Lake Arrowhead Water Agency has increased its rates 35.7%, effective July 1, 1993; and

WHEREAS, the service charge has remained unchanged since 1985 and increased costs are not reflected in the present charge;

BE IT, THEREFORE, ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Purpose - the purpose of this Ordinance is to establish and provide for water rates and charges on a monthly basis within the Deer Lodge Park Water System of the Lake Arrowhead Community Services District.

Section 2. Rates and Charges - the rates and charges for water provided by the Lake Arrowhead Community Services District to and within the Deer Lodge Park Water System are hereby established as follows:

Service charge (0 water usage)	\$22.00
0-500 cubic feet per 100 cubic feet	3.45
Over 500 cubic feet per 100 cubic feet	4.10

Section 3. A Water Connection fee for a new connection to the Lake Arrowhead Community Services Deer Lodge Park Water System is hereby established, as follows:

1. 5/8" meter \$3,553.00
2. 5/8" meter w/fire service. 4,291.00
3. 1" meter 3,654.00
4. 1" meter w/fire service. 4,291.00
5. 1-1/2" meter 4,059.00
6. 1-1/2" meter w/fire service. 4,831.00
7. 2" meter 4,831.00
8. 2" meter w/fire service. 5,031.00

The Water Connection charges combine the Facility Charge with the estimated cost of installing the meter.

Section 4. Applicability of other District rates, fees, and charges - All other Lake Arrowhead Community Services District rates, fees and charges are hereby applicable to the Lake Arrowhead Community Services District's Deer Lodge Park Water System. These charges include, but are not limited to, fire hydrant charges, reconnection charges, engineering and study review of new development charges, turn-on and turn-off fees, and all other existing rates, fees and charges, or such rates, fees and charges as may be adopted in the future.

Section 5. Effective date - This Ordinance shall become

effective July 1, 1993.


