

ORDINANCE NO. 38

**AN ORDINANCE OF THE BOARD OF DIRECTORS OF
THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA,
ADOPTING A NON SMOKING POLICY IN ALL FACILITIES
OF THE DISTRICT**

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District hereby finds that:

1. Numerous studies have found that tobacco smoke is a major contributor to indoor air pollution, and
2. Reliable studies have shown that breathing side stream, or second hand, smoke is a significant health hazard, especially for certain population groups, including elderly people, individuals with cardio-vascular disease, individuals with impaired respiratory functions, including asthmatics and those with obstructive airway disease, and
3. Health hazards induced by breathing side stream, or second hand, smoke include lung cancer, respiratory infections, decreased exercise tolerance, decreased respiratory functions, bronchial constriction, and bronchial spasms, and
4. Non smokers with allergies, respiratory diseases, and those who suffer other ill effects from breathing side stream, or second hand, smoke experience a loss of job productivity or may be forced to take periodic medical

leave because of adverse reactions to same, and

5. The Surgeon General of the United States has advised non smokers to avoid exposure to tobacco smoke wherever possible, and, in particular, to protect infants and children from the smoke, and
6. The smoking of tobacco is a proven danger to health, and
7. The health, safety, and general welfare of persons employed in, and persons who frequent, this District would be benefited by the regulations of smoking in enclosed spaces;

NOW, THEREFORE, IT IS ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District that smoking, including the carrying or holding of a lighted pipe, cigar, or cigarette of any kind, or any other lighted smoking equipment, or the lighting or emitting or exhaling the smoke of a pipe, cigar, or cigarette of any kind, is prohibited in all District buildings, facilities, and vehicles.


The Secretary is hereby authorized and directed to cause this Ordinance to be published once in full in the Mountain News and to have it posted in at least three (3) public places within the District.


