

ORDINANCE NO. 39

**AN ORDINANCE OF THE BOARD OF DIRECTORS OF
THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA,
PROVIDING FOR COMPENSATION OF MEMBERS OF
THE BOARD OF DIRECTORS
(See Resolution 94-10)**

**THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY
SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:**

Section 1. Purpose

This Ordinance is enacted pursuant to Section 20200 et seq. of the Water Code of California, which authorizes an increase in the amount of compensation above the amount of One Hundred Dollars (\$100.00) or more per day that each member of the governing board receives, provided that such increase does not exceed an amount equal to five percent (5%) for each calendar year following the operative date of the last adjustment, of the compensation which is received when the Ordinance is adopted.

Section 2. Compensation

The operative date of the last adjustment of the compensation received by each member of the Board of Directors was September 18, 1987, which amount of compensation is One Hundred Dollars (\$100.00) per day for each day's attendance at meetings of the Board of Directors or for each day's service rendered as a Director by request of the Board, not exceeding a total of six days in any calendar month.

Section 3. Increase of Compensation and Operative Date

A. On the first day of the month following the effective date of this Ordinance, each Director shall receive an increase in the amount of thirty percent (30%), based on five percent (5%) for each of calendar years 1988, 1989, 1990, 1991, 1992 and 1993, for a total of One Hundred Thirty Dollars (\$130.00) per day for each day's service rendered, not exceeding a total of ten (10) days in any calendar month.

B. On January 1, 1995, each director shall receive an increase of five percent (5%) for a total of One Hundred Thirty-six Dollars (\$136.00) per day for each day's service rendered, not exceeding a total of ten (10) days in any calendar month.

C. On January 1, 1996, each director shall receive an increase of five percent (5%) for a total of One Hundred Forty-three Dollars (\$143.00) per day for each day's service rendered, not exceeding a total of ten (10) days in any calendar month.

Section 4. Effective date

This Ordinance takes effect on the first day of the month following sixty (60) days from and after the date of its passage (August 1, 1994).


THE FOREGOING ORDINANCE was introduced at a meeting of


