

ORDINANCE NO. 5

ORDINANCE OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, ESTABLISH-
ING CHARGES FOR ENGINEERING AND STUDY REVIEW
OF NEW DEVELOPMENTS

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:


Section 1. Purpose. The purpose of this Ordinance is to establish charges for engineering and study review of new developments.

Section 2. Charges for Engineering and Study Review of New Developments. Each written request to the District for engineering or study review, site inspections and/or plan checks for new developments shall be accompanied with a minimum fee to the District of four hundred (\$400) dollars. The applicant shall be charged the actual cost of said engineering or study review, site inspection, and/or plan check and if the actual cost is greater than the four hundred (\$400) dollar fee paid to the District, the applicant shall be billed for the excess amount; if the actual cost of said engineering or study review, site inspection, and/or plan check is less than the four hundred (\$400) dollar fee paid to the District, the District shall refund to the applicant, the difference between the four hundred (\$400) dollar fee and the actual cost of the engineering or study review, site inspection and/or plan check.


Section 3. Effective date. This Ordinance shall become effective immediately.

Section 4. Publication. The Secretary is hereby directed to cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District within thirty (30) days after its adoption.




