

ORDINANCE NO. 50

**AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA**

**ADOPTING UPDATED RULES AND REGULATIONS FOR
WATER AND WASTEWATER SERVICE INCLUDING
ADOPTION AND ADJUSTMENT OF CERTAIN
SERVICE-RELATED FEES AND CHARGES**

WHEREAS, the Lake Arrowhead Community Services District wishes to update and revise its Rules and Regulations for Water and Wastewater Service including adoption and adjustment of certain service-related fees and charges; and

WHEREAS, the District conducted the following public awareness activities in order to provide customers and the community with information regarding the proposed adoption of the updated Rules and Regulations and the proposed adoption and adjustment of certain service-related fees and charges: (i) publications in the *Mountain News/Business Journal*; and (ii) newsletters included in the water and wastewater service bills; and

WHEREAS, the District held the following public meetings and conducted the following presentations during which information was provided regarding the proposed Rules and Regulations and the proposed adoption and adjustment of certain service-related fees and charges: (i) Regular Meeting of the Board of Directors on January 22, 2002; (ii) Workshop Meeting of the Board of Directors on February 12, 2002; (iii) Workshop Meeting of the Board of Directors on March 12, 2002; and

WHEREAS, this Ordinance was taken under consideration by the Board of Directors during its Regular Meeting on March 26, 2002, at which time the Board provided customers and the community with the opportunity to provide public comment and testimony. Notice of the time and date of the Regular Meeting was given in accordance with the requirements of California law for the posting of the notice and agenda for such a Regular Meeting.

**BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT AS
FOLLOWS:**

1. The Board of Directors hereby adopts the Rules and Regulations for Water and Wastewater Service, updated and dated as of March 26, 2002, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference.




