ORDINANCE OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, RESCINDING
ORDINANCES NO. 2, 3 and 4, AMENDING ORDINANCE
NO. 1 AND PROVIDING FOR METER INSTALLATION
CHARGES, BASIC FACILITIES CHARGES AND RECON-
NECTION CHARGES

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead
Community Services District as follows:

Section 1. Purpose. The purpose of this Ordinance is to amend
Ordinance No. 1 and to establish meter installation charges, basic
facilities charges and reconnection charges.

Section 2. Recision. Ordinances No. 2, 3, and 4 are hereby
rescinded in their entirety.

Section 3. Amendment. Section 3 of Ordinance No. 1 is hereby
amended to read as follows:

"Section 3. Meter Installation Charges, Basic Facilities
Charges, and Reconnection Charges.

(A) Meter Installation Charges. All applicants for
water service shall pay the actual cost of meter
installations for all new connections to the water
system; said actual cost of meter installation shall
be determined by the District and a deposit of
District's estimated cost shall be required of said
applicant prior to installation of the meter; in
the event that the actual costs exceed the estimated
costs, applicant shall pay District the difference;
and in the event that the estimated costs exceed the
actual costs, District shall refund the difference
to applicant.

- (B) Basic Facilities Charge. A basic facilities charge of four hundred forty two (\$442) dollars per unit connection is hereby established. The basic facilities charge shall be based on the equivalent dwelling unit which is defined for the purposes of this Ordinance, as follows: a single family residential unit; a single family cabin; an apartment unit; a condominium unit; a cottage; a motel or hotel unit with kitchen; each two (2) hotel or motel units without kitchen; and other commercial connections with fixture unit count of twenty plumbing fixtures or less which are not associated with living units.
- (C) Additional Water Facilities. The District may require the construction or acquisition of additional water facilities or appurtenances by the developer or applicant in addition to or in lieu of the basic facilities charge.
- (D) A charge of one hundred fifty (\$150) dollars for reconnection to the water system for each metered service is hereby established.


All applicants desiring new connections to the District water system shall submit payment for the basic facilities charge, based upon the number of equivalent dwelling units to be connected to the system with their application for water service."

Section 4. Effective date. This Ordinance shall become effective immediately.


Section 5. Publication, The Secretary is hereby directed to

cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District within thirty (30) days after its adoption.




