

**ORDINANCE NO. 72**

**AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE  
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,  
COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA  
RESCINDING ORDINANCES NO. 40, NO. 59, AND NO. 64 PREVIOUSLY  
ESTABLISHING VARIOUS RATES, FEES AND CHARGES FOR WATER, SEWER  
AND DEER LODGE PARK CUSTOMERS**

**WHEREAS**, the Lake Arrowhead Community Services District (“District”) has historically established service-related fees and charges for water and wastewater services by Ordinance adoption; and

**WHEREAS**, on or about October 20, 1994, the District adopted Ordinance 40, which established connection fees for the Deer Lodge Park Subdivision Water System; and

**WHEREAS**, on or about May 25, 2004, the District adopted Ordinance No. 59 which adopted certain service-related fees and charges to reflect the costs of providing the applicable services; and

**WHEREAS**, on or about January 24, 2006, the District adopted Ordinance No. 64 which adopted the Water Resource Fee for certain new connections to the system; and

**WHEREAS**, the District desires to rescind the existing ordinances establishing customer rates, fees, and charges in order to adopt revised rates, fees and charges by Resolution of the Board of Directors.

**THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY  
SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:**

1. Incorporation of Recitals:

The Recitals set forth above are incorporated herein and made an operative part of this Ordinance.

2. Rescission of Existing Ordinances:

Ordinance No. 40 adopted on or about October 20, 1994, Ordinance No. 59 adopted on or about May 25, 2004, and Ordinance No. 64 adopted on or about January 24, 2006 are rescinded and the fees and charges specified therein and in any other Ordinance pertaining to such fees and charges are rescinded and such fees and charges shall be established by Resolution. Upon the effective date of this Ordinance, the fees and charges set forth in Resolution 2008-12 shall be the effective fees and charges.
