

ORDINANCE NO. 8

ORDINANCE OF THE BOARD OF DIRECTORS OF THE  
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,  
SAN BERNARDINO COUNTY, CALIFORNIA, ESTABLISH-  
ING TURN-ON AND TURN-OFF FEE

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead  
Community Services District as follows:

Section 1. Purpose. The purpose of this Ordinance is to  
establish turn-on and turn-off fees for services requested by District  
customers or provided by the District for the customer's benefit.


Section 2. Turn-On and Turn-Off fee. A turn-on and turn-off fee  
of twenty dollars (\$20.00) is hereby established for a turn-on or a  
turn-off made by the District at the meter during normal District  
office hours. For a turn-on or a turn-off made by the District dur-  
ing non-office hours, on holidays or on weekends the fee shall be  
thirty-five dollars (\$35.00).

Section 3. Amendment by Resolution. The turn-on and turn-off fee  
as established herein may be increased or decreased from time to time  
by resolution of the Board of Directors.


Section 4. Effective date. This Ordinance shall take effect  
thirty (30) days after its adoption.

Section 5. Publication. The Secretary is hereby directed to  
cause this Ordinance to be published in full in a newspaper of general  
circulation within the District.




