

ORDINANCE NO. 9

ORDINANCE OF THE BOARD OF DIRECTORS OF THE  
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,  
SAN BERNARDINO COUNTY, CALIFORNIA, RESCINDING  
ORDINANCES NO. 2, 3, 4 AND 6, AMENDING ORDI-  
NANCE NO. 1 AND PROVIDING FOR METER INSTAL-  
LATION CHARGES, BASIC FACILITIES CHARGES  
AND RECONNECTION CHARGES

BE IT ORDAINED, by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Purpose. The purpose of this Ordinance is to amend Ordinance No. 1 and to establish meter installation charges, basic facilities charges and reconnection charges.

Section 2. Recision. Ordinances No. 2, 3, 4 and 6 are hereby rescinded in their entirety.

Section 3. Amendment. Section 3 of Ordinance No. 1 is hereby amended to read as follows:

"Section 3. Meter Installation Charges, Basic Facilities Charges, and Reconnection Charges.

(A) Meter Installation Charges. All applicants for water service shall pay the actual cost of meter installations for all new connections to the water system; said actual cost of meter installation shall be determined by the District and a deposit of District's estimated cost shall be required of said applicant prior to installation of the meter; in the event that the actual costs exceed the estimated costs, applicant shall pay District the difference; and in the event that the estimated costs exceed the actual costs, District shall re-


fund the difference to applicant.

- (B) Basic Facilities Charge. A basic facilities charge of five hundred fourteen dollars (\$514) per unit connection is hereby established. The basic facilities charge shall be based on the equivalent dwelling unit which is defined for the purposes of this Ordinance, as follows: a single family residential unit; a single family cabin; an apartment unit; a condominium unit; a motel or hotel unit; and other commercial structures with fixture unit count of twenty plumbing structures or less (as defined in the Uniform Plumbing Code). The basic facilities charge shall be periodically adjusted by resolution of the Board of Directors to reflect changes in the cost of living as reported in the National Figures of the "Engineering News Record Construction Cost Index".
- (C) A charge of one hundred fifty dollars (\$150) for reconnection to the water system is hereby established. All applicants desiring new connections to the District water system shall submit payment for the basic facilities charge, based upon the number of equivalent dwelling units to be connected to the system with their application for water service.

Section 4. Effective Date. This Ordinance shall become effective immediately.


Section 5. Publication. The Secretary is hereby directed to cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District within thirty (30) days after its adoption.




