

RESOLUTION NO. 2015-02

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, AMENDING THE FISCAL YEAR 2015/2016 BUDGET

WHEREAS, the Lake Arrowhead Community Services District (“District”) is organized and operates pursuant to the California Government Code Section 61000, *et seq.*; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District is required by California Government Code Section 61110(f) to annually adopt a budget prior to September 1st of each year or, for districts using two one-year budgets or a biennial budget, every other year; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District approved the Fiscal Year 2015/2016 Budget on June 10, 2014 at a public hearing; and

WHEREAS, the General Manager prepared and published the notice stating the time and place within the District that the proposed Fiscal Year 2015/2016 Budget was available for inspection. The notice was published at least two weeks before the hearing in at least one newspaper of general circulation in the District pursuant to Government Code section 6061; and

WHEREAS, California Government Code Section 61111(a) after the adoption of its final budget, the Board of Directors may adopt a resolution amending the budget; and,

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District desires to amend the Fiscal Year 2015/2016 Budget; and

THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

1. Incorporation of Recitals:

The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

2. Adopt the Budget Amendment:

The Draft Fiscal Year 2015/2016 Budget Amendment is adopted as the Final Fiscal Year 2015/2016 Budget.


