

## RESOLUTION NO. 2016-19

### **A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, RECOGNIZING AGENCIES, EMERGENCY RESPONDERS, FIREFIGHTERS, AND ORGANIZATIONS FOR THEIR EFFORTS DURING THE PILOT FIRE**

**WHEREAS**, The Pilot Fire started at about 12:10 p.m. on Sunday, August 7, 2016, near the Miller Canyon OHV area off of Highway 138. The Pilot Fire forced mandatory evacuations for the entire Deer Lodge Park community as well as homes along Aleutian Drive, Klondike Drive, Evergreen Lane and Yukon Drive and along Highway 173 north and south from Highway 138 to Arrowhead Lake Road; and

**WHEREAS**, the Pilot Fire was within less than half a mile from the District's Grass Valley Wastewater Treatment Plant; and

**WHEREAS**, Fire personnel were stationed at the plant 24 hours a day. Part of their efforts included gelling the methane tank, cutting large fire breaks and surrounding the plant with phos-chek; and

**WHEREAS**, the Board of Directors of the Lake Arrowhead Community Services District are honored to recognize the efforts of the fire crews for the importance they placed on protecting the plant and the efforts during the Pilot Fire and all of the following agencies, emergency responders, firefighters, and organizations: American Red Cross, Bureau of Land Management, Apple Valley Fire Protection District, Arrowbear Fire Department, Big Bear Fire Authority, CALFIRE, CALFIRE-Inyo-Mono-San Bernardino Unit California Dept. of Corrections, California Dept. of Transportation, California Highway Patrol, California Office of Emergency Services, California State Parks Idyllwild Fire Protection District, Kern County Fire Department, Los Angeles County Fire Department, Rancho Cucamonga Fire Protection District, Redlands Fire Department, Riverside Fire Department, Running Springs Fire Department, San Bernardino County Animal Control, San Bernardino County Fire Department, San Bernardino County Office of Emergency Services, San Bernardino County Sheriff's Department, San Diego Fire Department, and San Manuel Fire Department.


