

RESOLUTION NO. 2018-04

A RESOLUTION OF THE BOARD OF DIRECTORS OF LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, ADOPTING THE FISCAL YEARS 2018-19 AND 2019-20 BUDGET

WHEREAS, the Lake Arrowhead Community Services District ("District") is organized and operates pursuant to the California Government Code Section 61000, et seq.; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District is required by California Government Code Section 61110(f) to annually adopt a budget prior to September 1st of each year; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District has made the Draft Fiscal Years 2018/2019 and 2019/2020 Budget available to the public, published notice of a public hearing to consider the Draft Fiscal Years 2018/2019 and 2019/2020 Budget, held a public meeting on May 8, 2018, and a public hearing on June 26, 2018; to receive comments from interested parties regarding the Draft Fiscal Years 2018/2019 and 2019/2020 Budget; and

WHEREAS, the Board of Directors of the Lake Arrowhead Community Services District believes that the attached Draft Fiscal Years 2018/2019 and 2019/2020 Budget represents a responsible and balanced financial approach for the reliable operation and maintenance of the infrastructure and programs under its jurisdiction; and

WHEREAS, the General Manager has prepared and published a notice stating the time and place within the District that the proposed Fiscal Years 2018/2019 and 2019/2020 Budget is available for inspection; and

WHEREAS, the General Manager has prepared and published a notice stating the date, time and place when the Board of Directors will meet to adopt the Fiscal Years 2018/2019 and 2019/2020 Budget and that any person may appear and be heard regarding any item in the budget or regarding the addition of other items; and

WHEREAS, the notice was published at least two weeks before the hearing in at least one newspaper of general circulation in the District pursuant to Government Code section 6061; and

WHEREAS, the public hearing was held on June 26, 2018; and

THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

1. Incorporation of Recitals:

The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

2. Adopt the Budget:

The Draft Fiscal Years 2018-19 and 2019-20 Budget is adopted as the Final Fiscal Years 2018-19 and 2019-20 Budget.


