ORDINANCE NO. 1

ORDINANCE OF THE BOARD OF DIRECTORS OF
 THE LAKE ARROWHEAD COMMUNITY SERVICES
 DISTRICT, SAN BERNARDINO COUNTY,
 CALIFORNIA, ESTABLISHING AND PROVIDING
FOR WATER RATES AND CHARGES

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Purpose. The purpose of this ordinance is to establish and provide for water rates and charges on a bi-monthly basis.

Section 2. Rates and Charges. The rates and charges for water provided by the Water District are hereby established as follows:

METERED RATES AND CHARGES
OTHER THAN AGRICULTURAL

<u>BI-MONTHLY QUANTITY CHARGES</u>	<u>BI-MONTHLY RATES</u>
0 - 1,000 cubic feet	\$18.50
Over 1,000 cubic feet per 100 cubic feet	\$ 1.454

AGRICULTURAL RATES AND CHARGES
(METERED AND UNTREATED WATER SERVICE)

<u>BI-MONTHLY QUANTITY CHARGES</u>	<u>BI-MONTHLY RATES</u>
Per 100 acre feet	\$7500.00

FIRE HYDRANT CHARGES

<u>SIZE OF WATER MAIN</u>	<u>BI-MONTHLY RATES</u>
Water mains 6" and above	\$6.00
Water mains less than 6"	4.00

FIRE HYDRANT CHARGES
ON PRIVATE SERVICES

The fire hydrant charge for hydrants located on private service mains shall be \$2.00 bi-monthly for each inch in size of the private water main.


Section 3. Connection and Reconnection Charges. A charge of one hundred (\$100.00) dollars is hereby established for all new connections to the water system and for all reconnections to the water system. This charge shall be due and payable at the time of making application to the District for a water connection.

Section 4. Amendment by Resolution. The rates and charges established herein may be amended and changed from time to time by resolution of the Board of Directors.

Section 5. Effective Date. This ordinance shall become effective immediately upon acquisition of the domestic water system from the Arrowhead Utility Company by the Lake Arrowhead Community Services District.


Section 6. Publication. The Secretary is hereby directed to cause this ordinance to be published once in full in a newspaper of general circulation, printed, published and circulated in the District.




