ORDINANCE NO. 2

ORDINANCE OF THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT, SAN BERNARDINO COUNTY, CALIFORNIA, AMENDING ORDINANCE NO. 1 AND ESTABLISHING AND PROVIDING FOR WATER RATES AND CHARGES

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. <u>Purpose</u>. The purpose of this ordinance is to amend Ordinance No. 1 and to establish and provide for water rates and charges on a bi-monthly basis.

Section 2. Amendment. Section 3 of Ordinance No. 1 is hereby amended to read as follows:

"Section 3. Connection and Reconnection Charges. Charges of seven hundred (\$700.00) dollars for all new connections to the water system and one hundred fifty (\$150.00) dollars for all reconnections to the water system are hereby established. These charges shall be due and payable at the time of making application to the District for water connection."

Section 3. <u>Effective Date</u>. This ordinance shall become effective immediately upon acquisition of the domestic water system from the Arrowhead Utility Company by the Lake Arrowhead Community Services District.

Section 4. <u>Publication</u>. The Secretary is hereby directed to cause this ordinance to be published once in full in a newspaper of general circulation, printed, published and circulated in the District.
