

ORDINANCE NO. 3

ORDINANCE OF THE BOARD OF DIRECTORS OF
THE LAKE ARROWHEAD COMMUNITY SERVICES
DISTRICT, SAN BERNARDINO COUNTY,
CALIFORNIA, RESCINDING ORDINANCE NO. 2,
AMENDING ORDINANCE NO. 1 AND PROVIDING
FOR CONNECTION AND RECONNECTION CHARGES

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Purpose. The purpose of this Ordinance is to amend Ordinance No. 1 and to establish and provide for the applicability of connection charges.

Section 2. Recision. Ordinance No. 2 is hereby repealed and rescinded in its entirety.

Section 3. Amendment. Section 3 of Ordinance No. 1 is hereby amended to read as follows:

"Section 3. Connection and Reconnection Charges. Charges of seven hundred (\$700.00) dollars for all new connections to the water system and one hundred fifty (\$150.00) dollars for all reconnections to the water system are hereby established.

(a) All applications for new connections received prior to August 22, 1978 for properties that are in the course of construction shall not be subject to the connection charge. For the purpose of this Ordinance, 'in the course of construction' shall mean that a foundation is or will be in place on said property on or before August 22, 1978.

(b) All applications for new connections received prior to August 22, 1978 and for which subsection (a)


above does not apply shall be subject to the connection charge provided for herein, said connection charge to be paid on or before the time of installation of water service to the property.

(c) All applications for new connections received after August 21, 1978 shall be subject to the connection charge provided for herein and payment of said connection charge shall accompany said application."

Section 4. Effective Date. This Ordinance shall become effective immediately upon acquisition of the domestic water systems from the Arrowhead Utility Company by the Lake Arrowhead Community Services District.


Section 5. Publication. The Secretary is hereby directed to cause this Ordinance to be published once in full in a newspaper of general circulation within the District.
