ORDINANCE NO. 4

ORDINANCE OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, RESCINDING
ORDINANCES NO. 2 AND 3, AMENDING ORDINANCE
NO. 1 AND PROVIDING FOR CONNECTION AND RE-
CONNECTION CHARGES

BE IT ORDAINED by the Board of Directors of the Lake Arrowhead Community Services District as follows:

Section 1. Purpose. The purpose of this Ordinance is to amend Ordinance No. 1 and to establish and provide for the applicability of connection and reconnection charges.

Section 2. Recision. Ordinances No. 2 and 3 are hereby rescinded in their entirety.

Section 3. Amendment. Section 3 of Ordinance No. 1 is hereby amended to read as follows:

"Section 3. Connection and Reconnection Charges.

A charge of four hundred forty-eight (\$448) dollars as a basic facilities charge for future expansion of the water system is hereby established for all new connections to the water system. In addition, all applicants shall pay the actual cost of meter installations for all new connections to the water system; said actual cost of meter installations shall be determined by the District and a deposit of District's estimated costs shall be required of said applicant prior to installation of the meter; in the event that the actual costs exceed the estimated costs, applicant

shall pay District the difference; and in the event that the estimated costs exceed the actual costs, District shall refund the difference to applicant.

- (A) Notwithstanding any other provision contained herein, any applicant who submits an application for water service to the District on or before October 30, 1978 shall pay the actual cost of the meter installation, as provided for hereinabove, and shall not be responsible to pay the basic facilities charge for future expansion;
- (B) The provisions contained in Section 3(A) above shall apply only in the event that the property for which application for a new connection to the water system is being made are 'in the course of construction';
- (C) 'In the course of construction', for the purposes of this Ordinance, shall mean that a foundation is or will be in place on said property on or before April 30, 1979; and
- (D) Those applicants who have paid a connection charge pursuant to Ordinance No. 3 shall have their charge recomputed as to what their charge would have been pursuant to this Ordinance, if they qualify, and shall pay whichever charge is less.


In addition to the foregoing, a charge of one hundred fifty (\$150) dollars for reconnection to the water system

is hereby established."

Section 4. Effective Date. This Ordinance shall become effective immediately.


Section 5. Publication. The Secretary is hereby directed to cause this Ordinance to be published once in full in the Mountain News and in the Timberline Journal and to have it posted in at least three (3) public places within the District within thirty (30) days after its adoption.




