

RESOLUTION NO. 16

RESOLUTION OF THE BOARD OF DIRECTORS
OF THE LAKE ARROWHEAD COMMUNITY SERV-
ICES DISTRICT, SAN BERNARDINO COUNTY,
CALIFORNIA, REQUESTING THE CALIFORNIA
STATE LEGISLATURE TO ADD SECTION
61626.8 TO THE GOVERNMENT CODE.

WHEREAS, the Lake Arrowhead Community Service District was formed by vote of the people within the boundaries of the District with the express purpose of acquiring the domestic water system from the Arrowhead Utility Company in order to put that water system in public ownership; and

WHEREAS, there has been concern expressed regarding the retention of the private status of the waters and lake property of Lake Arrowhead; and

WHEREAS, this Board of Directors has determined that an addition to the Government Code could protect and preserve the private status of Lake Arrowhead and its waters:

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Lake Arrowhead Community Services District as follows:


Section 1. That the California Government Code be amended by adding the following:

"Section 61626.8 - Notwithstanding any other provision of law, whenever a District formed under this division acquires a water system which has as its source of water supply a privately owned lake or


reservoir, such water supply lake or reservoir will not become open for any use by the general public by virtue of such acquisition nor shall any existing rights with respect to such privately owned lake or reservoir be affected."

Section 2. That the Secretary is hereby directed to forward a copy of this Resolution to those State legislators representing the Lake Arrowhead Community.




