

RESOLUTION NO. 79-4

RESOLUTION OF THE BOARD OF DIRECTORS OF
THE LAKE ARROWHEAD COMMUNITY SERVICES
DISTRICT, SAN BERNARDINO COUNTY,
CALIFORNIA, PROVIDING FOR PAYMENTS ON
ACCOUNT OF SICKNESS; ESTABLISHING A
SEPARATE OBJECT OR SUBOBJECT SOLELY
FOR PAYMENTS ON ACCOUNT OF SICKNESS;
AND PROVIDING THAT SUCH PAYMENTS ON
ACCOUNT OF SICKNESS SHALL BE EXCLUDED
FROM SOCIAL SECURITY WAGES

WHEREAS, Chapter 491 (Assembly Bill 521) Statutes of 1979, effective on January 1, 1980, provides the authority for this District to establish a separate object or subobject of appropriation for making payments on account of sickness; and

WHEREAS, said Chapter, being Section 22017 of the Government Code, makes it possible to exclude said payments on account of sickness from Social Security wages:

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That payments to employees on account of sickness is hereby authorized; provided, however, that said payments will be in accordance with and subject to the sick leave regulations and limitations heretofore provided for by this District.

Section 2. That a separate object or subobject of appropriation within salaries and employee benefits for the payment of compensation to employees who are on approved leaves of absence on account of sickness is hereby established.

Section 3. That said payments on account of sickness shall be excluded from Social Security wages.






