

RESOLUTION NO. 4-80

RESOLUTION OF THE BOARD OF DIRECTORS  
OF THE LAKE ARROWHEAD COMMUNITY  
SERVICES DISTRICT, SAN BERNARDINO  
COUNTY, CALIFORNIA, INCREASING THE  
BASIC FACILITIES CHARGE AND THE  
DEVELOPERS EXPANSION FEE

WHEREAS, this Board of Directors has established a Basic Facilities Charge and a Developers Expansion Fee by adoption of Ordinances No. 9 and 11; and

WHEREAS, Ordinances No. 9 and 11 provide that the Basic Facilities Charge and the Developers Expansion Fee shall be periodically adjusted to reflect changes in the cost of living as reported in the National Figures of the "Engineering News Record Construction Cost Index":

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That the Basic Facilities Charge of the District is hereby increased to \$544.33 to reflect the increase in the cost of living through August.

Section 2. That the Developers Expansion Fee of the District is hereby increased to \$465.96 to reflect the increase in the cost of living through August.

Section 3. That these increases are effective as of the date of this Resolution.




