

RESOLUTION NO. 1-81

RESOLUTION OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, RESCINDING
RESOLUTION NO. 4-80 AND INCREASING THE BASIC
FACILITIES CHARGE AND THE DEVELOPER'S EXPAN-
SION FEE

WHEREAS, this Board of Directors has established a Basic Facilities Charge and a Developer's Expansion Fee by adoption of Ordinances No. 9 and 11; and

WHEREAS, Ordinances No. 9 and 11 provide that the Basic Facilities Charge and the Developer's Expansion Fee shall be periodically adjusted to reflect changes in the cost of living as reported in the national figures of the "Engineering News Record Construction Cost Index; and

WHEREAS, this Board of Directors has previously adopted Resolution No. 4-80 which increased the Basic Facilities Charge and the Developer's Expansion Fee in accordance with Ordinances No. 9 and 11:

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That Resolution No. 4-80 is hereby rescinded in its entirety.


Section 2. That the Basic Facilities Charge of the District is hereby increased by 4.78 percent to \$570.35 to reflect the increase in the cost of living through April, 1981.

Section 3. That the Developer's Expansion Fee of the District is hereby increased by 4.78 percent to \$488.23 to reflect the

increase in the cost of living through April, 1981.


Section 4. That these increases are effective as of the date of this Resolution.


