

RESOLUTION NO. 4-81

RESOLUTION OF THE BOARD OF DIRECTORS OF THE  
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,  
SAN BERNARDINO COUNTY, CALIFORNIA, DECLARING  
PROPERTY AND A WATER RESERVOIR TO BE SURPLUS  
TO THE DISTRICT NEEDS AND AUTHORIZING THE  
SALE OF SAID PROPERTY AND WATER RESERVOIR  
TO THE ARROWHEAD MANOR WATER COMPANY

WHEREAS, the District Board of Directors has determined that Lot No. 33 in Tract No. 2804 is surplus to the District needs; and

WHEREAS, said Lot has a small water reservoir located upon it and the District Board of Directors has determined that said water reservoir is surplus to the District needs; and

WHEREAS, the Arrowhead Manor Water Company has offered to purchase said parcel of property and water reservoir located thereon:

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That Lot No. 33, Tract No. 2804 and a water reservoir located thereon are hereby declared to be surplus to the needs of the District.


Section 2. That the Board of Directors does hereby accept the offer to purchase said surplus Lot and water reservoir submitted by the Arrowhead Manor Water Company.

Section 3. That the President and Secretary are hereby authorized to execute a deed conveying said property to the Arrowhead Manor Water Company upon receipt of payment therefor.


Section 4. That the staff is hereby directed and
