

RESOLUTION NO. 3-83

RESOLUTION OF THE BOARD OF DIRECTORS OF
THE LAKE ARROWHEAD COMMUNITY SERVICES
DISTRICT, SAN BERNARDINO COUNTY, CALIF-
ORNIA, INCREASING THE BASIC FACILITIES
CHARGE AND THE DEVELOPER'S EXPANSION FEE.

WHEREAS, this Board of Directors has established a basic facilities charge and a Developer's expansion fee by adoption of Ordinances Number 9 and 11; and

WHEREAS, Ordinances Number 9 and 11 provide that the basic facilities charge and the Developer's expansion fee shall be periodically adjusted to reflect changes in the cost of living as reported in the national figures of the "Engineering News Record Construction Cost Index"; and

WHEREAS, this Board of Directors has previously increased the basic facilities charge and the Developer's expansion fee in accordance with Ordinances Number 9 and 11:

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE and ORDER as follows:

Section 1. That the basic facilities charge of the District is hereby increased by 4.21% to \$657.05 to reflect the increase in the cost of living.

Section 2. That the Developer's Expansion Fee of the District is hereby increased by 4.21% to \$562.46 to reflect the increase in the cost of living.

Section 3. That these increases are effective as of the date of this Resolution.
