

RESOLUTION NO. 4-83

RESOLUTION OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, AUTHORIZING
THE GENERAL MANAGER TO ACCEPT AND CONSENT TO
ALL DEEDS OR GRANTS CONVEYING ANY INTEREST IN
REAL PROPERTY TO LAKE ARROWHEAD COMMUNITY
SERVICES DISTRICT FOR PURPOSES OF RECORDATION.

WHEREAS, Section 27281 of the Government Code provides that deeds or grants conveying any interest in real property to Lake Arrowhead Community Services District shall not be accepted for recordation without the consent of the Lake Arrowhead Community Services District; and

WHEREAS, Section 27281 of the Government Code provides that the Lake Arrowhead Community Services District, may by general resolution, authorize an officer to accept and consent to such deeds or grants;

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE and ORDER as follows:

Section 1. That the General Manager be and he hereby is authorized and directed to accept and consent, for purposes of recordation, to all deeds or grants conveying any interest in real property to the Lake Arrowhead Community Services District.

Section 2. That the Certificate of Acceptance to be used by the General Manager shall be in substantially the same form as Exhibit "A" attached hereto and incorporated herein.






