

RESOLUTION NO. 8-83

RESOLUTION OF THE BOARD OF DIRECTORS  
OF THE LAKE ARROWHEAD COMMUNITY SERVICE  
DISTRICT, SAN BERNARDINO COUNTY, CALI-  
FORNIA, AMENDING "RULES AND REGULATIONS  
FOR SEWER SERVICE" RELATING TO CONNECTION  
CHARGES AND INSPECTOR'S FEES AND ESTAB-  
LISHING AN APPLICATION FEE.

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE, and ORDER as follows:

SECTION 1. APPLICATION FEE. For each "Application for Sewer Service", applicant shall pay a fifty (\$50.00) dollar application fee at time of submittal by applicant in order to be accepted and considered by this District. This application fee is non-refundable and shall be used to pay District's cost of review and investigation of such application.

SECTION 2. PERMIT AND INSPECTION FEE. Section 10.1.01 of the District "Rules and Regulations for Sewer Service" is hereby amended to increase the Permit and Inspection Fee to fifty (\$50.00) dollars.

SECTION 3. MAIN SEWER CONNECTION CHARGE - SINGLE AND MULTIPLE FAMILY RESIDENCES. Section 10.1.03.1 of the District "Rules and Regulations for Sewer Service" is hereby amended to increase the minimum fee per living unit to two thousand five hundred seventy-one (\$2,571.00) dollars; in addition, the fee for living units with more than twenty (20) Fixture Unit Equivalents is increased to one hundred twenty-eight dollars and fifty cents (\$128.50) for each Fixture Unit in excess of twenty (20).

SECTION 4. MAIN SEWER CONNECTION CHARGE - ALL OTHER CLASSIFICATIONS. Section 10.1.03.2 of the District "Rules and Regulations for Sewer Services is hereby amended to increase the Main Sewer Connection Charges per assigned EDU to two thousand five hundred seventy-one (\$2,571.00)dollars.

SECTION 5. MAIN SEWER CONNECTION CHARGE - TIME OF PAYMENT. Section 10.1.02 of the District "Rules and Regulations for Sewer Service" is hereby amended to require that the Main Sewer Connection Charge shall be paid prior to the issuance by District of a sewer connection permit.

SECTION 6. DEFINITIONS. The District "RULES AND REGULATIONS FOR SEWER SERVICE", hereinafter referred to as "Rules", is hereby amended as follows:

(A) Wherever the terms "District" or "Lake Arrowhead Sanitation District" are used in the "Rules", they shall mean the Lake Arrowhead Community Services District.

(B) Wherever the terms "Board" or "Board of Supervisors" are used in the "Rules", they shall mean the Board of Directors of the Lake Arrowhead Community Services District.

(C) Wherever the term "Clerk to the Board of Supervisors" is used in the "Rules", it shall mean Secretary of the Lake Arrowhead Community Services District.


(D) Wherever the term "Special Districts Department" is used in the "Rules" it shall mean the Lake Arrowhead Community Services District.

(E) Wherever the term "Special Districts Director" is used in the "Rules" it shall mean the General Manager of the Lake Arrowhead Community Services District.


SECTION 7. EFFECTIVE DATE. This Resolution shall become effective immediately upon its adoption.

SECTION 8. PUBLICATION. The Secretary is hereby directed to cause this Resolution to be published once in full in a newspaper of general circulation within thirty (30) days of its adoption.


