

RESOLUTION NO. 3-85

RESOLUTION OF THE BOARD OF DIRECTORS OF THE
LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT,
SAN BERNARDINO COUNTY, CALIFORNIA, EXPRESSING
THEIR OPPOSITION TO ASSEMBLY BILL 165.

WHEREAS, the Lake Arrowhead Community Services District currently levies a water standby or availability charge within the District pursuant to the Community Services District Law; and

WHEREAS, Assembly Bill 165, introduced by Assemblyman Roos, would amend the general Community Services District Law, specifically that portion commencing with Section 61765 and dealing with water standby or availability charges; and

WHEREAS, this amendment would curtail and limit the ability of the Lake Arrowhead Community Services District to levy and collect the water availability or standby charge, thus potentially reducing or limiting the revenue produced by said water standby or availability charge:

NOW, THEREFORE, the Board of Directors of the Lake Arrowhead Community Services District does hereby RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That the Lake Arrowhead Community Services District Board of Directors does hereby express its opposition to Assembly Bill 165.

Section 2. That the Secretary is hereby directed and authorized to forward copies of this Resolution to all legislators representing either the area encompassed by Lake Arrowhead Community Services District or the County of San Bernardino.






