

**RESOLUTION NO. 2015-07**

**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT ADOPTING THE REPORT OF THE ANNUAL WASTEWATER SERVICE FEES AND DIRECTING THE GENERAL MANAGER OF THE DISTRICT TO FILE SAID REPORT WITH THE SAN BERNARDINO COUNTY AUDITOR AND REQUEST THE AUDITOR PLACE THE FISCAL YEAR 2015/2016 WASTEWATER SERVICE FEES ON THE TAX ROLL**

**WHEREAS**, pursuant to Resolution No. 2014-14 (the "Resolution"), on December 16, 2014 the Lake Arrowhead Community Services District ("District") adopted rates for its Wastewater Service Fees (the "Fees") pursuant to California Government Code Section 61115 *et seq.*; and

**WHEREAS**, the District has determined to impose the Fees on all properties located within the District that receive wastewater services in accordance with the Resolution and California Government Code Section 61115 *et seq.*; and

**WHEREAS**, the District has determined to impose increases to the Fees on all properties located within the District that received wastewater services from January 1, 2015 through June 30, 2015 but were not charged the increase as adopted on December 16, 2014 and effective as of January 1, 2015; and

**WHEREAS**, certain properties within the District receive sewer services but do not receive water services; and

**WHEREAS**, the District has determined that it is appropriate to collect the Fees, back charged increases and delinquencies, and any penalties related thereto for such properties on the tax roll in the same manner as property taxes in accordance with California Government Code Section 61115(b); and

**WHEREAS**, the General Manager of the District has prepared and filed a written report (the "Report"), a copy of which is attached hereto as Exhibit A, and by this reference incorporated herein, with the Board of Directors of the District that describes these certain parcels of real property subject to the Fees, the amount of the Fees, the amount of applicable back charged increases to the Fees, any delinquencies, and any penalties to be imposed thereon for Fiscal Year 2015/2016; and

**WHEREAS**, the General Manager of the District has caused notice of (i) the filing of the Report proposing to have such Fees, applicable back charged increases to the Fees, any delinquencies, and any penalties to be imposed thereon for Fiscal Year 2015/2016 collected on the tax roll in the same manner as property taxes; and (ii) the time and the date of hearing to consider such Report (a) to be mailed to each affected property owner, and (b) to be published in the newspaper, all in accordance with the California Government Code Section 61115(b); and

**WHEREAS**, at the time stated in the notice, the Board of Directors conducted the public hearing and heard and considered all objections and protests to the Report; and

**WHEREAS**, the District has determined to adopt the Report and collect the Fees, applicable back charged increases to the Fees, any delinquent Fees, and any penalties on the tax roll, which Fees, applicable increases to the Fees, delinquent Fees, and penalties shall constitute a lien against the parcel or parcels of real property described in the Report in accordance with California Government Code Sections 61115 *et seq.*;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE LAKE ARROWHEAD COMMUNITY SERVICES DISTRICT AS FOLLOWS:**

Section 1. The Board of Directors hereby finds and determines that the Recitals are true and correct and are incorporated herein and findings of the Board of Directors.

Section 2. The Board of Directors hereby finds and determines that the Fees, applicable increases to the Fees, the delinquent Fees, and any penalties shall be imposed on and shall constitute a lien against each parcel or parcels of real property as set forth and described in the Report.

Section 3. The Board of Directors of the District hereby adopts the Report. On or before the 10<sup>th</sup> day of August, 2015, the General Manager is hereby directed to file a copy of the Report with the San Bernardino County Auditor, together with a statement endorsed thereon over his signature that the Report has been adopted by the Board of Directors and shall request that the Fees, applicable increases to the Fees, any delinquencies, and any penalties be collected on the tax bills for the taxable parcels in the District identified in the Report along with the ordinary *ad valorem* property taxes to be levied on and collected from the owners of said parcels.
