Hello everyone,

Attached are the September 2018 Monthly/Quarterly Reports.

- In September 2018 (159.79 AF), consumption was 10.4% higher when compared to September 2017 (144.73 AF). Through the 1st 9 months of 2018 consumption is down 9.3% (1052.10 AF) compared to the 1st 9 months of 2017 (1159.44 AF). These numbers are based off of column (12) on the Report, and only counts water delivered to the Distribution System.
- September 2018 Lake Draw = 93.38 AF vs September 2017 = 82.36 AF. Through the 1st 9 months of 2018 lake withdrawals are down 18.4% (751.12 AF) compared to the 1st 9 months of 2017 (920.54 AF).
- September 2018 Wells to System = 13.54 AF vs September 2017 = 13.57 AF. Through the 1st 9 months of 2018 "Wells To System" is down 13.7% (106.17 AF) when compared to the 1st 9 months of 2017 (122.96 AF).
- September 2018 total CLAWA purchase = 60.52 AF vs September 2017 = 54.70 AF. Through the 1st 9 months of 2018 CLAWA purchase = 247.03 AF compared to the 1st 9 months of 2017 = 146.62 AF.

Attached is the September 2018 GV Wells and Recycled Water Monthly/Quarterly Report.

- September 2018 Wells to System = 13.54 AF vs September 2017 = 13.57 AF. Through the 1st 9 months of 2018 "Wells To System" is lower (106.17 AF) when compared to the 1st 9 months of 2017 (122.96 AF).
- September 2018 ALA Well #8 production = 619,117 gallons = 1.90 AF = 827.69 CCF.
- September 2018 Recycled Water delivered = 39.23 AF vs September 2017 = 20.01 AF. Through the 1st 9 months of 2018 Recycled Water delivered = 239.88 AF compared to the 1st 9 months of 2017 = 194.94 AF.
