Dear Diana,

This letter responds to your request for records under the California Public Records Act (Gov. §§ 6250 – 6276.48), received via email on March 15, 2019. You requested the following information:

(1) I would like to have a copy of the W-9 Form and if you have any tax-exempt forms as in a Resale Certificate or other. I am looking for the tax status for Lake Arrowhead CSD.

In response to item 1, the District is providing a copy of Lake Arrowhead Community Services District Form W-9 Request for Taxpayer Identification Number and Certification, as an email attachment. With regards to “Resale Certificate or other” we do not have a “Reseller Certificate” our District is not exempt from sales tax.

Please be advised that the District has redacted Employer Identification Numbers (EINs) in the responsive documents. The redacted numbers are confidential financial information. Public disclosure of such information could compromise the financial security of the business and expose the District to liability. Therefore, the public interest served by withholding the redacted information clearly outweighs any public interest served by disclosure (Gov. Code § 6255).



Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
